The Retailer membership category shall include any corporation or person whom:

- is an authorized, full service bicycle retailer with a storefront in a legally zoned area carrying the appropriate governmental permits and registrations for retail sales, having normal business hours during a minimum yearly period of six months;
- does not operate, own or have interests, whether direct or indirect, in any manufacturing, importing, and wholesaling facility;
- has had a minimum of one year of history in the Canadian bike trade;
- is solvent and of good reputation;
- has its principal place of business within Canada.
- Individual franchisees shall not be entitled to vote as a regular member of BTAC but shall be part of their respective franchising network or organization which shall be entitled to one vote per franchising network or organization.
